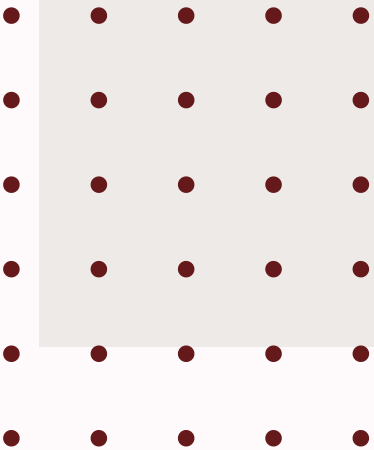
KAA Members and Guests,

BATTLE OF THE BLUEGRASS OPEN BID CALLING AND RINGMAN CHAMPIONSHIP

This was the fifth year for the Kentucky Auctioneers Association Battle of the Bluegrass Open Bid Calling Championship, which has become one of the largest bid calling competitions in the nation, focusing on the live auction method of marketing. We had a big change this year with the help of the Kentucky Department of Agriculture and the Kentucky State Fair Board, we were able to hold this year's contest at the Kentucky State Fair on the second Saturday of the Fair, August 19th. The State Fair venue was great, we were right between the North and South hall and had in and out public traffic all day long.

We had 25 contestants in the Open Bid Calling from all over the country including Arizona, Texas, Georgia, Ohio, Indiana & beyond. We had 6 in our Junior Competition, as well as 6 in the Ringman Competition. Our panel of judges for 2023 were as follows: Johnathan Noel, owner of Noel Auctioneers in Alton, KY and the first Champion of the Battle of the Bluegrass, David Whitaker, owner of Whitaker Marketing Group, Huxley, IA and the 2022 Champion of the Battle of the Bluegrass, the "Alabama Hammer" Mr. Wayne Thorn, ringman extraordinaire, Prattville, AL, Eddie Ables, owner of EA Realty and Auctioneers, Columbia, TN and Chairman of the Columbia Breakfast Rotary Club Mule Days Auctioneer Championship, and rounding out this year's panel is Mr. James Benton Pendleton, Salt Lick, KY, the 2023 World Champion Automobile Auctioneer.

The day started on Saturday with the Junior contest. In this contest we had a tough field with the newly crowned 2023 International Junior Auctioneer Championship Champion - Brandon Mendoza from Oklahoma and several others from Kentucky, Tennessee, and Missouri. In the end, Brandon Mendoza was crowned the Junior Champion with Ty Wood of Benton, KY taking Reserve Champion.

The Open Bid Calling Championship was next and as I said earlier it was a tough field with several state champions competing. In the end, it came down to these top five: Jason Miller, OH, Champion, Will Gregory, KY, Reserve Champion, Troy Robinette, TX, Third Place, Joshua Houston, TN, Fourth Place, and Jeremy Garber, MO, Fifth Place.

The Ringman Contest is run just a little differently as there is no set prize money. It is set up as a Jackpot with the winner receiving the majority of the entry fee money. We had several compete this year from Kentucky, Georgia, Alabama, and Tennessee. We got to see the chemistry of a father-son team with the Houston's from TN, the always exciting Mr. Dustin Mallory, but this year's Ringman Champion was Taylor Osborn, GA, with Joshua Houston, TN, taking Reserve Ringman Champion. This is a fun contest and is growing each year. It does show the benefit and teamwork a Ringman can bring to get top dollar for your product no matter what you are selling.

I would like to thank all of our Sponsors and the Kentucky Auctioneers Association Board Executive Committee along with the Battle of the Bluegrass Committee, along with our Executive Director, Cali Crissup and Amber Traub for all of their help in making this event a success. This is the only event the association holds to raise money for the scholarship fund. If you haven't attended the event before, we hope you will join us in 2024 at the Sixth Annual Battle of the Bluegrass during the Kentucky State Fair in Louisville, KY.

I would also like to thank all the Competitors over the years, it is because of you we have made this contest what it has become. We look forward to seeing all of you in 2024 to see who will take home the title of Champion from the Battle of the Bluegrass.



CELEBRATING

Judy Taylor

Judy Taylor was born July 18 in Louisville, Kentucky. The year is more closely held than many national security secrets. She went to be with her Lord and Savior on October 12, 2023. Judy grew up in New Mexico with life leading her across the world. She traveled extensively, living in both England and Israel. She began her lobbying career as a volunteer for the Kentucky Association of Older Persons in 1976. She made ends meet by substitute teaching. Judy became the first female contract lobbyist, blazing a trail for many to follow. If there was one word to sum her up, it would be mighty.

She: Mightily embraced her faith. Mightily loved her family. Mightily watched over her clients, especially Keeneland. Mightily embraced the role of Capitol Mother and Grandmother to hundreds. Mightily embraced life and all that was good. Mightily embraced the spread of kindness.

If Judy met someone that put up a wall, she burst right through it. Everything Judy did, she did at full throttle. The stories of her kindness and generosity are too many to recount. In just one instance of many, she visited a Christian bookstore in Lexington and struck up a conversation, as is her way, with a nice young clerk. On her next visit, she sought him out and continued the conversation. He told her he was a theology student, working his way through Asbury. She called Asbury and anonymously paid his entire tuition for the rest of his time there.

If you were a new lobbyist, you were told by everyone on your first day, "You'd better go see Judy." If you heard "Judy is looking for you," it could go one of two ways. You were getting a cookie or a dressing down. And you better see her right away. You never had to wonder where you stood with her. If you were a new legislator, you didn't have to look for her. She was one of the first people to welcome you to Frankfort. She was the lobbyist chosen to speak at New Member Orientation and always there to offer counsel... and cookies.

Cookies are a recurrent theme in summing up Judy. There is no telling how many thousands of cookies she baked over the years. If you heard the word "cookie," you knew exactly what was being referenced; you knew exactly who baked them and their one-of-a-kind taste. They represent an outreach of caring and love that she was willing to freely give. In a 2010 article about her in *Governing Magazine*, she said there is no way to separate the part of her that gave away cookies as a lobbyist and the part of her that did it for simple pleasure and friendship.

Everyone has a "Judyism" too numerous to relay. She also had her vices. We all remember her standing outside in the cold, wearing a mink coat, smoking her Wave Ultra Lights behind the Annex. Dr. Pepper cans were never out of reach and her famous desk was always stocked. She had a way with "direct" speaking. If she had dessert at a restaurant, she would invariably tell the server her desserts were better, after she had told them exactly how to cook her meal. And they'd better have a full bowl of sugar for her iced tea with lemon but no ice. And what does a tiny person of a certain age need in her life? Well of course, her beloved Doberman, Dilly. Even though Dilly outweighed Judy and stood half as tall as she did, there was no doubt who was in charge.

Judy knew exactly who she wanted to be. Her high school yearbook quote sums it all up. "Why make a mark on the world, when I can scribble all over it." May we all celebrate her life and lessons. Scribble on the world with joy and kindness...and be mighty.

Judy is survived by her daughter, Maresa Taylor (Randy) Fawns of Shelbyville and son, Paul Taylor of Naples, Italy, three grandchildren, Joseph Thomas (Allison) Fawns, Samuel Reese Fawns, and Kennedy Ann Taylor, a brother, John Harris, a half sister, Norela Harrington, and an army of "adopted" family members and friends.

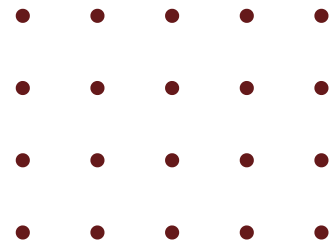

CONTEST RULES



What to expect at the Annual Convention:

1. The Kentucky Auctioneers Association auctioneering contests shall be open to any auctioneer holding a valid Kentucky Auctioneers License and residing in the state of Kentucky
2. The contest shall consist of the following: a. Ringman Contest: Open to any Kentucky resident. b. Division 1- Apprentice Division: Open to any Kentucky auctioneers who have been licensed three (3) years or less, whether an Apprentice or Principal Auctioneer. Contestants in this division cannot enter the Professional Division contest. c. Division 2-Female Division: Open to any licensed female Kentucky auctioneer. Contestants in this division may also enter the Professional Division d. Division 3-Professional Division: Male or Female. This contest shall determine the Kentucky State Champion Auctioneer. Auctioneers licensed less than three (3) years may enter the Professional Division.
3. Each contestant in ALL Divisions must be a member in good standing of the Kentucky Auctioneers Association, Inc during the year which the contest is held.
4. Each contestant must be registered for the convention at which the contest is held.
5. Ringman contestants will be judged during the Fun Auction. The contestant may designate an auctioneer to be calling bids while being judged. The entry fee shall be \$100.00.
6. Contestants in the Apprentice Division and the Female Division shall provide (3) items with an approximate value of \$50.00 each. Contestants will sell the items which they have brought for the contest. All proceeds from the sale of the items remain with the Kentucky Auctioneers Association. Contestants in these divisions shall pay an entry fee of \$100.00.
7. The Professional Division shall consist of two (2) rounds, a preliminary round and a final round. Each contestant shall provide three (3) items with an aggregate value of \$200.00 which the contestant will sell in the preliminary round. Items to be sold must be received by 4:30 PM on the day of the contest. Items to be sold in the final round will be provided by the Association. All proceeds from the sale of these items remain with the Kentucky Auctioneers Association. The entry fee for the Professional Division shall be \$150.00.
8. Based on the judges scores, three (3) contestants shall be selected to participate in the final round. In the event there are more than 14 contestants, or other unusual circumstances, the Bid Calling Committee, in consultation with the judges, may bring back more than 3 finalists.
9. During the final round, the finalists will answer one question and sell two (2) items, which will be provided by the Association. The question will be the same for every contestant. Therefore, contestants will be sequestered out of earshot of the contest until time to participate. Each contestant will have one minute to answer the question.
10. Winner awards shall be as follows: a Ringman: Winner shall receive a \$100 cash award, a belt buckle, a suitable trophy, and the opportunity to Ring for the Battle of the Bluegrass Open Bid Calling Contest. Runner-up will receive a \$50 cash award & trophy. b Apprentice Division: Winner shall receive a \$100 cash award, belt buckle and a suitable trophy. The Runner-Up will receive a \$50 cash award and a suitable trophy. c Female Division: The winner shall receive a \$250 cash award & a suitable trophy. The First Runner-Up shall receive a \$150 cash award and a suitable trophy. The Second Runner-Up shall receive a \$100 cash award and a suitable trophy. d Professional Division: The winner shall receive a \$500 cash award; a suitable trophy; belt buckle; entry fee paid for the International Auctioneering Championship (IAC) to be held at the NAA Conference and Show, permission to use 'Kentucky State Champion Auctioneer' in their advertising and promotion materials, and serve as the auctioneer for the Farm Bureau Country Ham Auction, provided the Kentucky Farm Bureau continues to request that service. The First Runner-Up shall receive a \$250 cash award and a suitable trophy. The Second Runner-Up shall receive a \$100 cash award and a suitable trophy. Should the winner be unable or unwilling to participate in the IAC or the Country Ham Auction, the First Runner- Up will be given the opportunity to represent the KAA.
11. Decisions of the judges are final and may not be appealed.
12. Junior Contest: Open to any Kentucky Youth, Non Licensed, 18 & Under. Must bring 2 items to sell. Any additional questions, please contact Cali Crissup, KAA Executive Director, 580-327-7525
